## **USING MYPROAG**

#### Create your account and password

- 1. Visit **my.proag.com** and fill out the registration form.
- 2. Check the email associated with your new myProAg account for a **confirmation email.**
- 3. The link will take you to a new screen to **create a unique password** and create your account.
- 4. You'll be redirected to set up multifactor authentication.

Multifactor authentication creates an additional layer of security for your myProAg account. When enabled, it helps protect your account even if someone learns your password.

#### Link your policy or policies

If your policy is under your social security number, it will automatically populate in myProAg.

If your policy is under an Employer Identification Number (EIN), you will need to link your policy with these steps.

- 1. Click Find My Policy.
- 2. Complete all the required fields.
- 3. Check your dashboard and confirm your policy or policies have appeared.

#### Paying your bill online is easy

- 1. Click the Pay My Bill tab on the left side of the screen, then Make Payment at the top.
- 2. Choose the product(s) for which you'd like to pay.
- 3. Enter the payment amount.
- 4. Click Bank Account to enter your banking information and then Continue.
- 5. Review the **Confirm Payments** screen, check the box to authorize and click **Pay**.



**Tip:** Print out the confirmation screen to keep a record of your payments.
